Presentation of the Call 3 – Definition

To support **900 Seal of Excellence laureates** from EIC Accelerator, awarded later than June 2021 (SoE awarded before cut-off in June 2021 are not eligible).

KPIs:	<ul style="list-style-type: none">- 900 SoEs supported by the EEN2EIC project- 450 SoEs will apply for funding- 112 SoEs will receive the funding

EEN members will be involved:

- as **Group Leaders** (coordinators) for organising matchmaking activities at the country or multi-country level.
- as **Local Nodes** for supporting the local beneficiaries.

EEN2EIC consortium will provide a model blueprint of support activities, as well as digital tools, know-how, and its network for access to public and private investments.

Presentation of the Call 3 – Group Leader: Eligible Conditions

Necessary:

- to be a member of Enterprise Europe Network (EEN) and be part of existing EEN Consortium at the time of application.
- to ensure appropriate track record in providing innovation support services to SMEs.
- to provide well-good network with other EEN consortium partners as well as a network of regional innovation ecosystems.

Preferably:

- to have enough personal resources to support Seal of Excellence holders (in case of Group Leaders (GL) it is coordination of Local Nodes (LN) and organization of e-pitches)
- to have knowledge of national innovation funding landscape/programs of several countries
- to have knowledge of Venture capital (VC) country/region landscape
- to have experiences coaching and pitching enterprises to present in front of VC
- to have knowledge of Horizon Europe ecosystem



Presentation of the Call 3 – Group Leader: Eligible Activities

GL is the connection between EEN2EIC project and its group of EEN countries:

- To **coordinate and support** LNs within the designated region:
 - to support LNs in their cooperation with SOE SMEs in obtaining finance from private and public sources.
 - to prepare and update on the regular base the list of possibilities of funding from public sources.
- To add the national investors and public funders to EEN2EIC e-community,
- To update an e-pitches planning, training and coaching services of selected SoE startups and logistic details.
- To participate on **onboarding webinars and coaching workshops** organized by Bpifrance in the context of this project.
- GL will be responsible for supporting Bpifrance in **preparation of the e-pitching calendar.**



Presentation of the Call 3 – Group Leader: Eligible Activities

- GL will organize e-pitches:
 - selecting companies from nominations provided by LNs and provide the pre-pitch coaching for selected companies.
 - inviting local and national investors to the e-pitches.
 - follow up the pitching companies and will provide additional matchmaking services for introduction the companies to the investors.
 - to provide all necessary data and contacts needed for reporting to Bpifrance, European Innovation Council (EIC) and EEN.
- Other responsibilities of GLs:
 - monitoring and updating the information about the regional / national EU innovation funding programmes relevant to SOEs.
 - to be active in the implementation of the project and must coordinate their actions with Coordination office.
 - to be a member of the selection committee for Local Nodes in their groups.

Local Nodes (LN) – local EEN members

One EEN member supporting SoE holders in their region / EEN consortium will be selected as a Local Node for the WP3 – Support of Seal of Excellence holders.

LN's will closely cooperate with selected GLs in their groups and LN will be in charge of the direct communication and provide direct support to SoE companies in the regions defined as their scope of action.

In specific cases, if the consortium considers that is necessary to identify more than one LN for the successful implementation of activities listed in section 3.3 of the call, more than one Local Node (LN) per consortium could be selected.

The Selection will be made to enable full coverage of the country and the consortium area and avoiding overlapping covered regions.

- to contact and to support directly SoE holders in designated area / EEN consortium
 - to add the local investors and public funders to EEN2EIC e-community,
 - to add and onboard SoE startups to EEN2EIC e-community.
 - to participate on onboarding webinars and coaching workshops organized by Bpifrance in the context of this project.
 - to select and nominate the SoE companies for e-pitch and provide their contacts to GLs.
 - to invite the local investors to the e-pitches organized by Group Leader.
 - to recommend the national public possibilities to SoE companies and support them if they decide to apply.
 - to follow up the pitching companies and provide additional matchmaking support for introduction the companies to the investors.
- To be active in the implementation of the project and must coordinate their actions with GL.
