1.1. Deadline extension for applying to the Open Call for Group Leader and Local Nodes (Open_Call 3)

The new deadline to apply for Group Leader position (Open Call 3) is **03.04.2023 at 17:00 CET (Brussels Time)**.

1.2. Deadline extension for Partners impacted by the catastrophic earthquakes of February 2023 in Turkey

Following the series of tragic natural events occurred in Turkey in February 2023 and following the requests from different stakeholders involved in the project, EEN2EIC will grant additional 90 days to apply to EEN2EIC Call 3: Open Call for Group Leaders and Local Nodes (SoE) [<https://een2eic.eu/call-3-open-call-for-group-leaders-and-local-nodes-soe-guide-for-applicants/>] for Turkish EEN Members.

With this addendum is created a new position of Group Leader for Group M for SoEs located in Turkey.

The deadline to apply for Group Leader position for Group M for Turkish EEN members is therefore **26.06.2023 at 17:00 CET (Brussels Time)**.
