

## Group Leader: Activities

GL is the connection between EEN2EIC project and its group of EEN countries:

- To **coordinate and support** LNs within the designated region:
  - to support LNs in their cooperation with SOE SMEs in obtaining finance from private and public sources.
  - to **prepare and update** on the regular base the list of possibilities of funding from public sources.
- To add the national investors and public funders to EEN2EIC e-community,
- To update an e-pitches planning, training and coaching services of selected SoE startups and logistic details.
- To participate on **onboarding webinars and coaching workshops** organized by Bpifrance in the context of this project.
- GL will be responsible for supporting Bpifrance in **preparation of the e-pitching calendar**.

## Group Leader: Activities

- GL will organize e-pitches:

- selecting companies from nominations provided by LNs and provide the pre-pitch coaching for selected companies.
- inviting local and national investors to the e-pitches.
- follow up the pitching companies and will provide additional matchmaking services for introduction the companies to the investors.
- to provide all necessary data and contacts needed for reporting to Bpifrance, European Innovation Council (EIC) and EEN.

- Other responsibilities of GLs:

- monitoring and updating the information about the regional / national EU innovation funding programmes relevant to SOEs.
- to be active in the implementation of the project and must coordinate their actions with Coordination office.
- to be a member of the selection committee for Local Nodes in their groups.

## Local Node: Activities

LN is the **connection** between EEN2EIC project and each SoE holder and regional innovation ecosystems:

- to contact and to support directly SoE holders in designated area / EEN consortium
  - to add the local investors and public funders to EEN2EIC e-community,
  - to add and onboard SoE startups to EEN2EIC e-community.
  - to participate on onboarding webinars and coaching workshops organized by Bpifrance in the context of this project.
  - to select and nominate the SoE companies for e-pitch and provide their contacts to GLs.
  - to invite the local investors to the e-pitches organized by Group Leader.
  - to recommend the national public possibilities to SoE companies and support them if they decide to apply.
  - to follow up the pitching companies and provide additional matchmaking support for introduction the companies to the investors.








# EuroQuity : Organization of e-pitching sessions



The European Innovation Council and EuroQuity-Bpifrance organized a pitching event for investors focused on cybersecurity. **Eight EIC-backed SMEs were selected by investors** and had the chance to present their innovative solutions during an online event to a board of jury members, consisting of representatives from VC funds: 3VC, Ace Capital Partners, Adara Ventures, Armilar, Caixa Capital Risc, Crane Ventures, eCapital, Evonik, JCI Ventures - Johnson Controls, KPN Ventures, Lightbird Ventures & Marcau Partners, NGP Capital, Orevon Venture Partners and SONAE IM. Following this session, investors were invited to schedule one-to-one meetings and one company was selected as the best pitch of the day.

The Taftie High Potential Community aims to promote **best-in-class SMEs with strong innovation potential coming from all European countries and selected by the Innovative Agencies**, members of Taftie. European and international investors can access this unique and very qualified deal flow through **3 e-pitching sessions per year**, and all along in the Taftie High Potential Community on EuroQuity. For each pitch session, at least **8 companies coming from 8 different countries** are invited to showcase their businesses. Following the session, investors can schedule **1-to-1 meetings** with each entrepreneur. The goal is to provide selected innovative companies with new opportunities to support their growth on a continental level.







### EIC epitching with investors on Aerospace and Aeronautics powered by EuroQuity – April 20<sup>th</sup>




